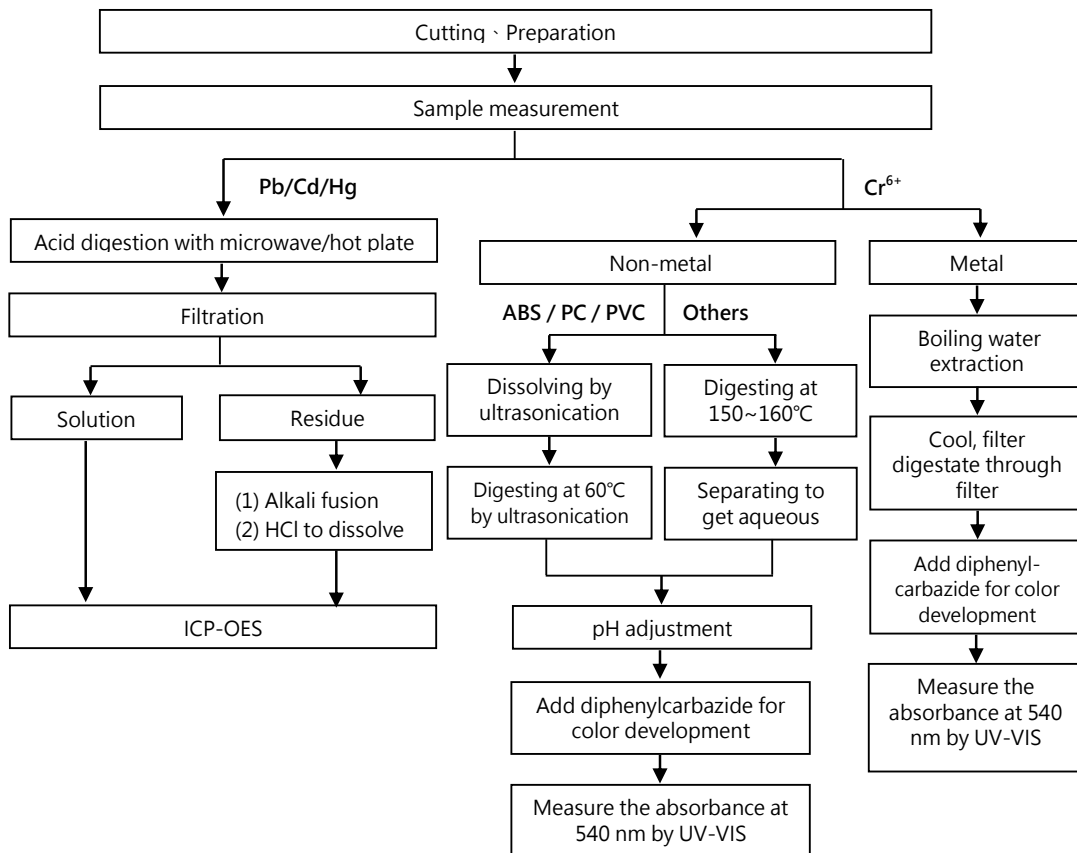

Analytical flow chart of Heavy Metal

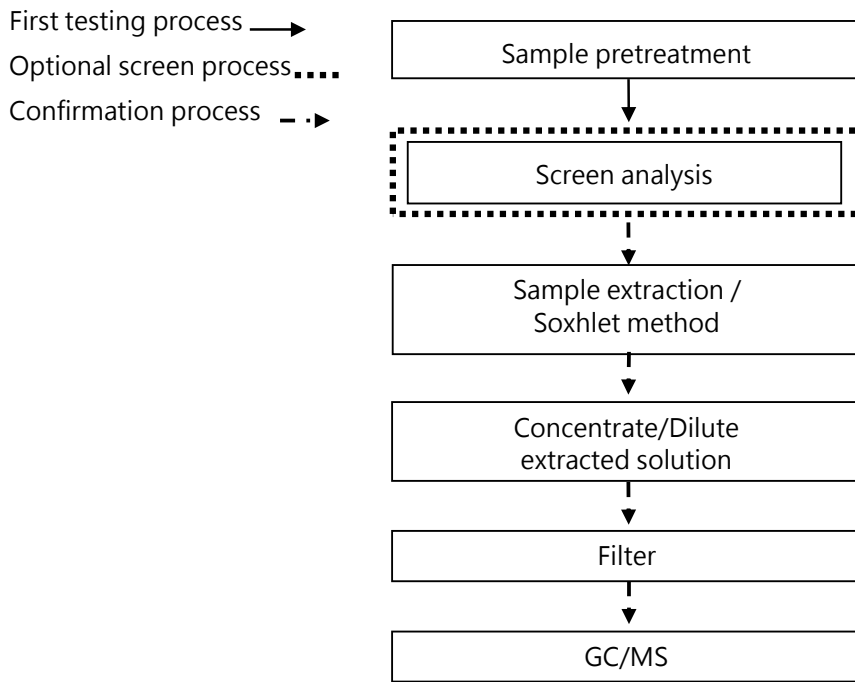

Analytical flow chart – PBBs / PBDEs



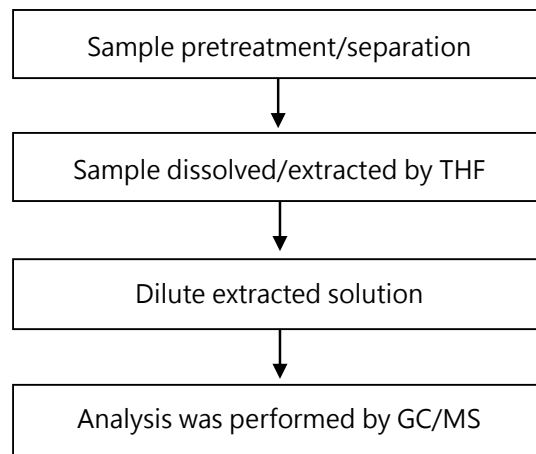

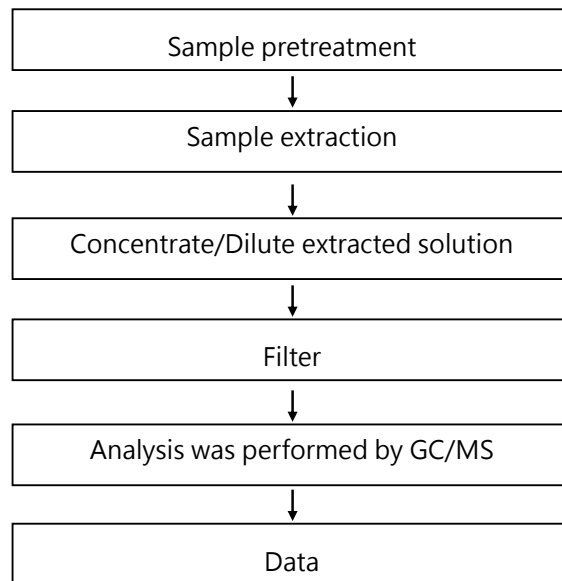
Analytical flow chart - Phthalate

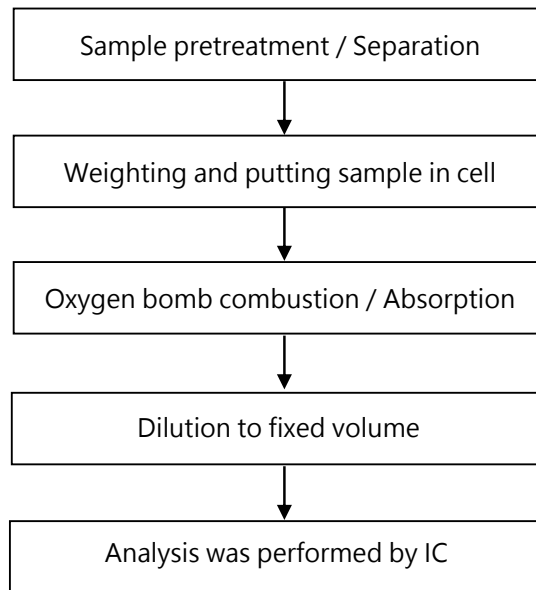

Analytical flow chart - HBCDD



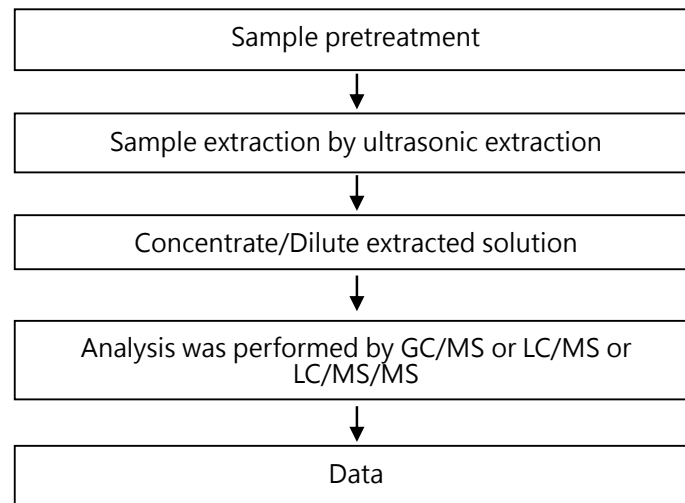

Analytical flow chart - Halogen



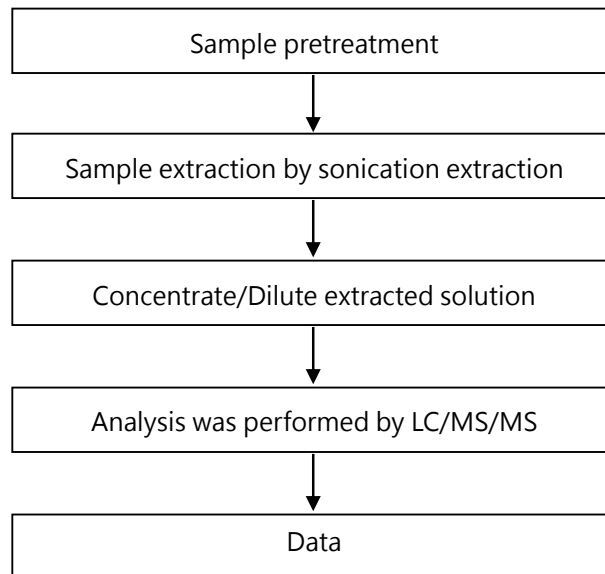

Analytical flow chart - Bisphenol A

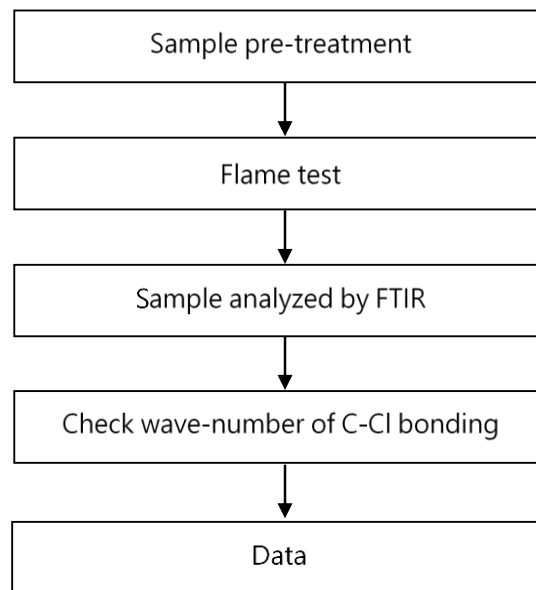

Analysis flow chart - PVC

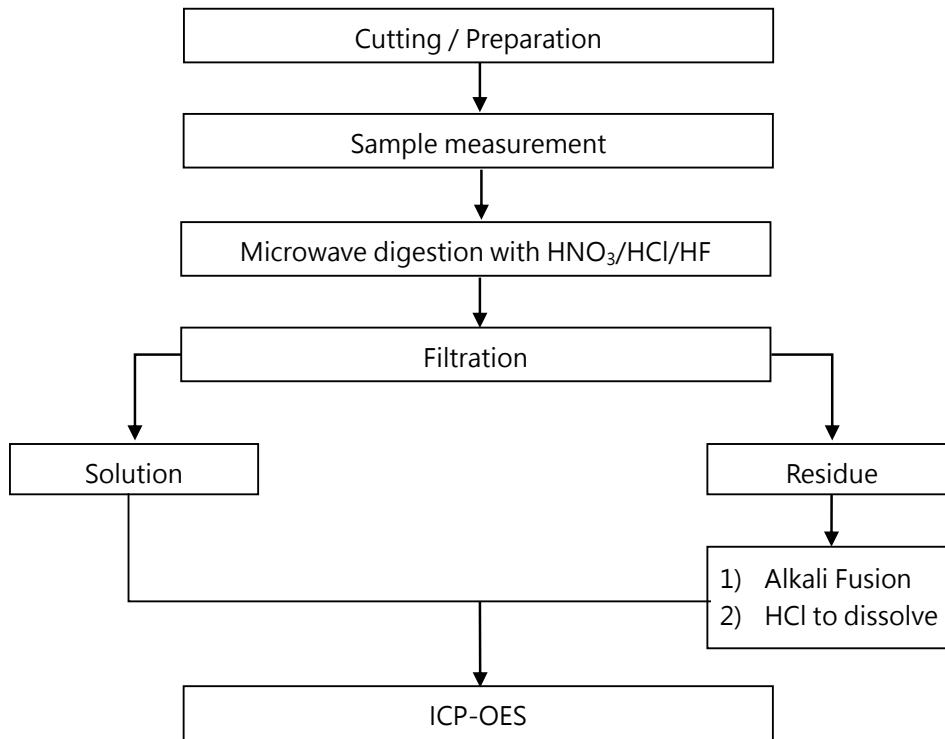

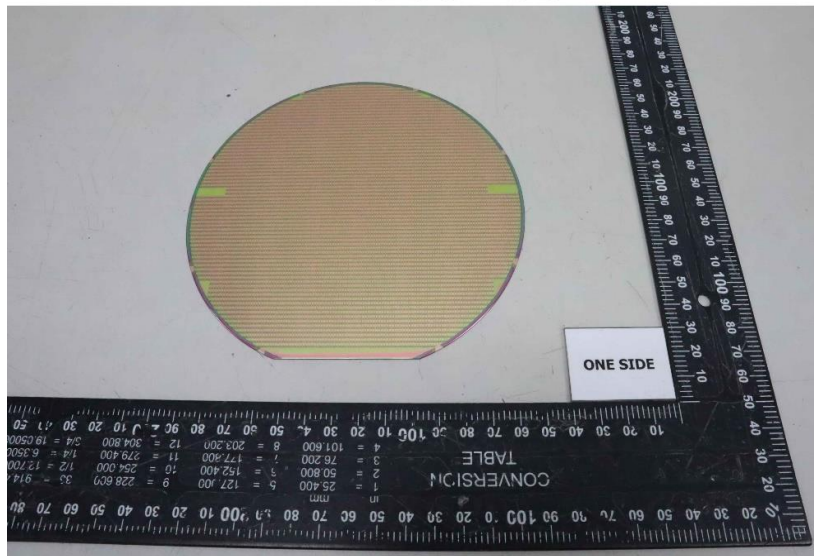

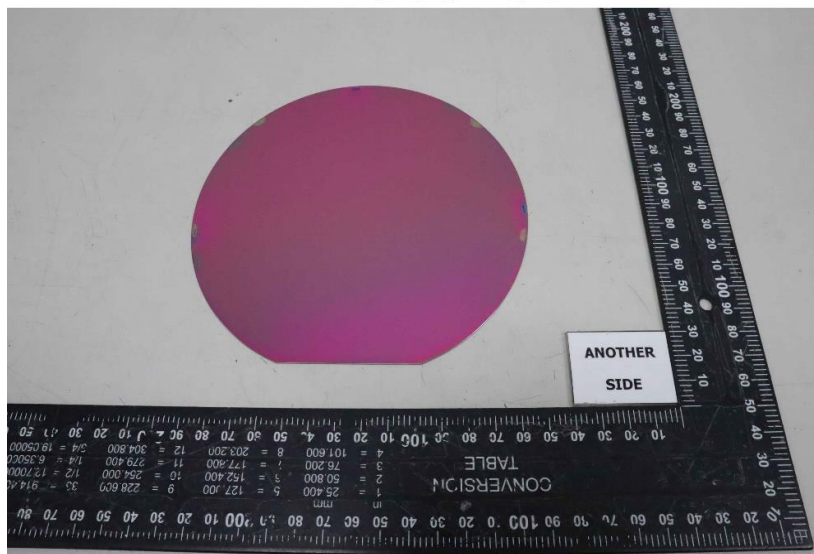
